Below are some editorial comments from Charlie on NEI 07-03, rev 6. Would it be possible for you to email us a draft revision 6A which incorporates the items below? The safety evaluation is in progress.

Editorial Comments on NEI 07-03, Rev 6:

0. Change the revision number in the Acknowledgements and Executive Summary Section
1. Use bold lettering for all of the bracketed items (on pages 6, 8, 11, 12, 15, 18, and 25).
2. (p. 3, VII) Add a comma after "independent of".
3. (p. 9, Respirator Facility) Capitalize the words "respirator facility" in line 6 of this section.
4. (p. 10, Facility for Dosimetry Processing and Bioassay) Delete the reference to Regulatory Guide 8.26 in line 7 in order to be consistent with the rest of the template.
5. (p. 13, 12.5.4) In line 6, replace the word "the" (after "8.10") with "and the consolidated".
6. (p.15, 12.5.4.2) Delete the second sentence ("Prior to and during refueling, purification of the refueling pool waerr continues.") under the heading "Refueling" and add the following sentence ("The Radiation Work Permit (RWP) system is used to maintain positive radiological control over work in progress.") prior to the sentence beginning with "By following...".
7. (p.15, 12.5.4.2) Since the section entitled "Inservice Inspection" describes inservice inspections and not jobs, specifically, make the following changes to this section; a) in line 4, replace the first word "job" with "inspection/job" and replace the second word "job" with "inspection", b) in line 6, delete the word "job".
8. (p.16, 12.5.4.2) Under the heading "Spent Fuel Handling", put a period after the word "cask" in the second sentence in the second paragraph. Modifiy the last line in the second paragraph to read "This minimizes the amount of hand cleaning needed to decontaminate the cask."
9. (p.17, 12.5.4.2) Under the heading "Sampling", make the following changes to the second paragraph; a) add the words "when taking samples" at the end of the first sentence, b) Add the following words to the beginning of the second sentence, "When taking liquid samples," and c) add the following sentence following the second sentence, "Care is taken to minimize spills."
- 10 (p.18, 12.5.4.3) In the last line in this subsection, change the word "Contaminated Areas" to "Contamination Areas".
11. (p. 18, 12.5.4.4) In the fifth line in the fourth paragraph of this section, change the word "Contaminated" to "Contamination".
12. (p. 21, 12.5.4.7) Under heading "II", insert the word "that" after the word "assure" in line 4.

13. (p. 22, 12.5.4.8) In the first line of the third paragraph, change the word "Contaminated" to "Contamination".
14. (p. 23, 12.5.4.8) Add a comma after the word "practical" in the eighth bullet.
15. (p. 25, 12.5.4.12) Since the bracketed phrase in Section 12.5.4.12 is an item that the applicant must address (i.e., applicant must reference the appropriate section in Chapter 17 or other document), insert the word "Note:" prior to the word "Reference" in the bracketed phrase.
