In utilizing the 45 day extension to the comment period in the Federal Register pertaining to the NRDC's Petition For Rulemaking to Ban Future Civil Use of Highly Enriched Uranium, our plea joins with others who are aware that highly enriched uranium is a very population threatening commodity to be available anywhere, and that it is conducive to fabrication of either sophisticated or crude nuclear weapons by non nuclear weapons states and others who threaten the integrity of the United States. That its security has frequently been compromised, is a matter of considerable documentation. Its existence constitutes a significant part of those potential, but very real threats to our national security from nuclear hazards of which have been alerted by presidents, presidential candidates, statesmen and military leaders.

Therefore it should be banned from present and future civilian use.
