The purpose of the meeting was to present and discuss research performed with the aim of developing a risk-informed basis for a revision of 10 CFR 50 Appendix G. The NRC staff, contractors, and the industry representatives reviewed recently performed work and indicated that they were aiming to present a document. This document would detail their proposed technical basis for the adoption of risk-informed margins in Appendix G of ASME Section XI, to which Appendix G of 10 CFR 50 references, at the November 2008 ASME Boiler and Pressure Vessel Code meeting. Staff and industry representatives agreed to meet again in a public forum in October of 2008 to exchange information prior to the Code meeting.
