SUBJECT: REPORT TO CONGRESS CONCERNING RECERTIFICATION OF THE  
PADUCAH GASEOUS DIFFUSION PLANT AND THE PORTSMOUTH  
GASEOUS DIFFUSION PLANT

Dear Mr. Brown:

The U.S. Nuclear Regulatory Commission (NRC) staff has reviewed and approved the requests from the U. S. Enrichment Corporation, dated April 11, 2008, for renewal of the Certificates of Compliance (COC) for both the Paducah Gaseous Diffusion Plant, located in Paducah, Kentucky, and the Portsmouth Gaseous Diffusion Plant, located in Piketon, Ohio. A notice of the intent to approve the applications and opportunity to petition for review was published in the *Federal Register* on October 22, 2008 (73 FR 63033). No comments were received. A copy of the staff's Compliance Evaluation Reports, as well as the renewed COC, are available within the NRC Publicly Available Records component of NRC's Agencywide Documents Access and Management System (ADAMS) under accession number ML082890780.

The Atomic Energy Act, as amended, requires that the NRC report to Congress, in consultation with the U. S. Environmental Protection Agency and the U. S. Department of Energy, on the status of health, safety, and environmental conditions at the gaseous diffusion plants (GDPs), no later than the date on which a COC is issued. Further, the report must include a determination of the extent to which the GDPs are in compliance with the standards established by the NRC.

On December 17, 2008, the NRC issued the required Report to Congress, which covers the period from October 1, 2003 to September 30, 2008. A copy of the Report to Congress is enclosed for your information. We appreciate your timely and comprehensive input, which was a major factor in the timely completion of this project.
