The purpose of this modification is to:

- (1) revise the labor hour requirements for Schedule A-1 Year 3 (BASE), to reflect a decrease in the amount of Contract Line Item Number 0003C by \$211,533.05 from \$10,101,812.20 to \$9,890,279.15, as a result of amending the total estimated hours. As a result, the total estimated cost of the task order is decreased by \$211,533.05 from \$37,757,231.87 to \$37,545,698.82.
- (2) revise the labor hour requirements for Schedule A-1 Year 4 (OPTION), to reflect an increase in the amount of Contract Line Item Number 0004 by \$203,470.40 from \$9,135,350.00¹ to \$9,338,820.40 as a result of amending the total estimated hours. As a result, the total estimated cost of the subject task order is increased by \$203,470.40 from \$37,545,698.82 to \$37,749,169.22.
- (3) revise Subsection H.17.1 - Key Personnel; and
- (4) incorporate Subsection H.28 - Personnel Change Notification.

Accordingly, the following changes are hereby made:

As a result of the above increases and decreases, the total estimated cost of Schedule A-1 Year 3 (BASE) is hereby decreased by \$211,533.05 from \$10,101,812.20 to \$9,890,279.15.

3. Revise Subsection H.17.1 to amend the contractor's key personnel;
