Dear Chairman McDade and Board Panel Members:

As you know from the August 28, 2008 Status Report provided by the NRC Staff, on August 26, 2008, the federal district court jury in the criminal trial of Andrew Siemaszko returned a guilty verdict on three of five counts of the criminal indictment. Sentencing is not expected to occur until at least 15 weeks from the date of the verdict. The undersigned counsel for Mr. Siemaszko intends to file motions pursuant to Rules 29 and 33 of the Federal Rules of Criminal Procedure, and will appeal the verdict, if necessary.

We respectfully request that Mr. Siemaszko's Enforcement Action matter continue in abeyance for at least the next month in order for counsel to file its post-trial motions and assess the impact of the criminal ruling on Mr. Siemaszko's Enforcement Action matter.
