Reference Task Order 2, Environment Administration, under Delivery Order DR-33-07-358.

The purpose of this modification is to (1) increase the task order ceiling, and (2) revise the price schedule, as follows:

1. Increase the ceiling of this task order by \$69,535.77, from \$590,549.59 to \$660,085.36. This ceiling increase is necessary to accomplish the requirements of this task order.
2. Replace the existing price schedule with the attached revised price schedule, dated August 14, 2008, listing labor categories, hourly rates, and hours, for a total ceiling amount of \$660,085.36.

This modification does not obligate any funding. The obligated amount remains at \$590,549.59.

All other terms and conditions of the subject task order remain unchanged.
