
The purpose of this modification is to provide incremental funding in the amount \$6,000.00 thereby increasing the the total obligations from \$39,798.80 to \$45,798.80. Accordingly the contract is modified as follows:

Refer to Section A.2 entitled, "Consideration and Obligation - Cost Reimbursement (June 1988)" paragraph (b) is deleted in its entirety and replaced with the following:

"(b) The amount obligated by the Government with respect to this contract is \$45,798.80."

All other terms and conditions remain unchanged including the contract ceiling of \$46,751.00.
