NUCLEAR POWER (NP) RADIOLOGICAL EMERGENCY PLAN (REP) REVISION 27

In accordance with the requirements of 10 CFR Part 50, Appendix E, Section V, and 10 CFR 50.54(q), enclosed is Revision 27, dated May 31, 1996, to TVA's consolidated NP REP. This revision reflects changes made to the generic part of the REP, Browns Ferry Nuclear Plant's Appendix A, Sequoyah Nuclear Plant's Appendix B, and Watts Bar Nuclear Plant's Appendix C to the NP REP. TVA has determined that these changes do not decrease the effectiveness of the plan and the plan, as changed, continues to meet the requirements of 10 CFR 50, Appendix E. Also enclosed is an effective page listing, table of contents, and revision log.

On May 1, 1996, TVA Nuclear announced interim organizational changes which impact the REP's organizational description. These interim changes were made to ensure additional management attention to nuclear oversight. When finalized, these organizational changes will be reflected in a future update to the REP.

The enclosed information is being sent by certified mail. The signed receipt signifies that you have received this information and will be taken as verification that the NRC copies of the plan have been updated, and the superseded material has been destroyed.
