The purpose of this modification is to:

1. Incorporate FAR clause 52.217-9 - Option to Extend the Term of the Contract.
2. Exercise Option Year #1.
3. Increase the ceiling of the Delivery Order.

Delivery Order NRC-DR-10-08-400 is hereby modified as follows.

1. FAR clause 52.217-9 – Option to Extend the Term of the Contract is hereby incorporated into the Delivery Order.

“The Government may extend the term of this contract by written notice to the Contractor within 15 days; provided that the Government gives the Contractor a preliminary written notice of its intent to extend at least 30 days before the contract expires. The preliminary notice does not commit the Government to an extension. If the Government exercises this option, the extended contract shall be considered to include this option clause. The total duration of this contract, including the exercise of any options under this clause, shall not exceed September 30, 2012.”

2. Option Year #1 is hereby exercised in accordance with FAR clause 52.217-9. The period of performance is hereby extended to 9/30/2009.
3. The ceiling of the Delivery Order is hereby increased by \$27,364.00 from \$27,124.40 to \$54,489.30.
