

The purpose of this modification is to provide incremental funding in the amount of \$85,183.00 thereby increasing the amount by \$85,183.00 from \$257,300.00 to \$342,483.00. Therefore, the contract is modified as follows:

1. Section A.14 CONSIDERATION AND OBLIGATION-DELIVERY ORDERD (JUN 1988), first sentence paragraph (b) is deleted and substituted with the following in lieu thereof:

“(b) The amount presently obligated with respect to this contract is \$342,483.00.”
