EXTENSION TO REQUEST FOR ADDITIONAL INFORMATION REGARDING THE
SPENT FUEL POOL STORAGE LICENSE AMENDMENT REQUEST

Dominion Nuclear Connecticut, Inc. (DNC) submitted a stretch power uprate (SPU) license amendment request (LAR) for Millstone Power Station Unit 3 (MPS3) in letters dated July 13, 2007 (Serial Nos. 07-0450 and 07-0450A). The SPU LAR included a revised spent fuel pool (SFP) criticality analysis with proposed changes in technical specification (TS) requirements. DNC separated the MPS3 SFP TS change request from the MPS3 SPU request via letter dated March 5, 2008 (Serial No. 07-0450D).

Subsequently, the Nuclear Regulatory Commission (NRC) sent DNC a request for additional information (RAI) via letter dated August 8, 2008. DNC had requested 45 days to respond to the RAI questions (due September 22, 2008). DNC has determined that an additional 15 days is necessary to provide the RAI response (with a new due date of October 7, 2008). This extension was discussed between Ms. Carleen Sanders, the NRC Project Manager, and Mr. Geoffrey Wertz during a phone call conducted on September 16, 2008.
