Enclosed is AmerenUE's response to the NRC's request for additional information (RAI) that was transmitted to AmerenUE (Union Electric Company) by NRC letter dated July 15, 2008 (Reference 1). The RAI concerns the control systems vulnerability issue that has been identified for the industry and which prompted an initial request from the NRC to all nuclear power plant licensees on June 22, 2007 (Reference 3) to provide information regarding the vulnerability and plant safety/security implications of this issue. AmerenUE responded to the NRC's initial information request by letter dated August 20, 2007 (Reference 2).

The NRC's recently transmitted RAI letter requests additional information in regard to the information originally provided in AmerenUE's Reference 2 response letter. The requested additional information is hereby provided in the enclosure to this letter and in accordance with the 60-day response time specified in the RAI letter.

As noted in the RAI letter, a list of specific RAIs was compiled for the industry such that not every RAI was transmitted to each licensee. The RAIs transmitted to each licensee therefore are not numbered in a continuous sequence since only the RAIs applicable to a particular licensee were transmitted to that licensee. For AmerenUE, only RAIs 2, 3, 7, 8, 9, 10, 11, 12, 22 and 23 were transmitted for response. With respect to the NRC's RAI letter, the RAIs addressed in the enclosure to this letter are numbered the same way. In addition, AmerenUE's responses to the RAIs are provided in the table format recommended per the RAI letter.

Please note that the information provided in Enclosure 1 is security-related information that is considered to be sensitive. Therefore, AmerenUE requests that the contents of the enclosure be withheld from public disclosure in accordance with 10 CFR 2.390.
