ENVIRONMENTAL REPORT SUPPLEMENTAL INFORMATION

Dominion plans to submit an update to the North Anna Unit 3 Combined License Application (COLA) to the NRC in December 2008. This update will incorporate previous responses to NRC requests for information and include additional environmental information as described in Enclosures 1 and 2.

Enclosure 1 is a summary of updated information to be included in the Environmental Report (ER). It also lists affected ER sections and provides an impact assessment of whether previous ER conclusions concerning the significance of impacts will be affected.

In addition, in a document dated June 16, 2008, the NRC identified four environmental information needs which were discussed during the April 2008 environmental site audit. Information is provided in Enclosure 2.

The responses in Enclosure 2 contain proprietary information that should be withheld from public disclosure pursuant to 10 CFR 2.390. A redacted version of the enclosure is provided as Enclosure 3. 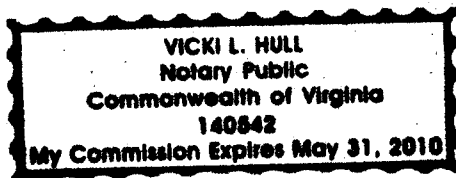



AFFIDAVIT OF EUGENE S. GRECHECK


I, Eugene S. Grecheck, Vice President – Nuclear Development of Virginia Electric & Power Company, dba Dominion Virginia Power (Dominion), being duly sworn according to law, depose and state the following:

1. I am authorized to execute this affidavit on behalf of Dominion.
2. Dominion's response to NRC's environmental information needs request designated as Enclosure 2 in Dominion letter No. NA3-08-108 in the North Anna COL proceeding contains certain proprietary commercial information that should be held in confidence by the NRC pursuant to 10 CFR 9.17 (a)(4) and 2.390 (a)(4). The proprietary commercial information is identified in the enclosure by bracketed text and marginal annotations. This information should be withheld from public disclosure because:
 - a. The information is and has been held in confidence by Dominion.
 - b. This information is of a type that is held in confidence by Dominion, and there is a rational basis for doing so because the information relates to ongoing, sensitive commercial negotiations;
 - c. This information is being transmitted to the NRC in confidence.
 - d. This information is not available in public sources and could not be gathered readily from other publicly available information.
 - e. Public disclosure of this information would create substantial harm to Dominion by potentially disrupting the commercial negotiations.
3. Accordingly, Dominion requests that the designated proprietary information in the enclosure identified above be withheld from public disclosure pursuant to 10 CFR 2.390(a)(4) and 9.17(a)(4).
