Dear Administrative Judges:

In the September 18, 2008 Order, the Licensing Board noted that all parties and the Licensing Board would tour the Pine Ridge Indian Reservation on October 2, 2008 (unless argument finishes early on October 1st).

Petitioners respectfully suggest that the Pine Ridge tour be fixed for the afternoon of October 2, 2008, leaving Chadron at 1:00pm after the lunch break that will follow the Crow Butte mine site tour. In order to properly prepare the tour, we need to have a confirmed date.

Previous to the September 18th Order, Petitioners had been planning a tour to start in the morning at the Black Hills Wild Horse Sanctuary. Since the tour will be shortened to just the afternoon of October 2, we will have to focus on taking everyone to Slim Buttes (home of several Petitioners and where The White River flows through), to Pine Ridge Village (for coffee/snacks, etc.) and to Manderson (where Petitioner White Plume lives and The White River flows). We expect the Pine Ridge tour to end at about 4:30pm at the Wounded Knee Memorial which is on the way back from Manderson to Pine Ridge towards Chadron. We will be stopping at the Wounded Knee Memorial to pay respects and say a prayer as is customary. If any member of the tour does not wish to stay for the Wounded Knee Memorial part of the tour, they are free to return to Chadron.

Petitioners respectfully suggest that if oral argument finishes early on October 1, an informal tour could be taken up to the Wild Horse Sanctuary where Petitioner Dayton Hyde and the 500 Wild Mustangs reside. It is about 1.5 hours from Chadron and we can arrange a short bus tour of the Wild Horse Sanctuary which shows the conjunction of the rivers. Since the tour of the Wild Horse Sanctuary is not contemplated by the September 18th Order, we understand that it may not be possible to visit it, especially if oral argument does not finish early on October 1st.
