- FSAR "incorporate by reference" ESBWR DCD Rev. 4
- No Early Site Permit
- Second S-COL for ESBWR design centered working group sections standardized with R-COL (North Anna) & site-specific sections
- Three "Exemptions" & "Departures"
- Acceptance Review (AR) process
 - analogous to other S-COL acceptance reviews (i.e., Lee, Harris)
 - use Office Instruction NRO-REG 100
 - Attachment G, Guide for SCOL referencing design certification
 - PM assignments for Branches on SharePoint

Staff Overview

Review Highlights (continued)

- SCOL review concurrent with ESBWR DC, RCOL and SCOL reviews
- Acceptance Review for SCOL "complete & technically sufficient"
 - confirm IBR sections, no EPM task (P1,P2)
 - confirm STD sections match RCOL sections, no EPM task (P1,P2)
 - modify application review schedule, as appropriate (P1, P2)
 - DC technical issues remain in DC not AR issue
 - RCOL technical issues remain in RCOL, for standard sections
 - not an SCOL AR issue
- SCOL technical review schedule dependent on RCOL completion (which is dependent on DC completion – can't issue COL prior to certification)
