SUBJECT: Summary of Conference Call with Applicant on June 11, 2008

On June 11, 2008, NRC staff participated in a telephone conference call with TVA representatives and observers (see list below) regarding the staff's detailed review of the Bellefonte Units 3 and 4 COLA. The purpose of the call was to discuss TVA's response to request for additional information (RAI) 2.5.2-1 regarding the Eastern Tennessee Seismic zone. TVA provided a response to this RAI in two phases: 1) a response dated 3/19/2008 (ADAMS accession number ML081070473) and 2) response dated 5/30/08 (ADAMS accession number ML081550232) that references an NEI white paper dated May 14, 2008 (ADAMS package ML081420023).

The staff indicated that it was reviewing the site specific aspect of TVA's response as it relates to the Dames and Moore study. The staff requested, and TVA agreed, that TVA will provide the raw data that was used to develop the curves in TVA's 3/19/2008 response. TVA would provide this information as a supplement to the RAI response. The staff indicated that it would use this information to perform an assessment as to whether or not a followon RAI would be needed in this area.
