REFERENCE: LIC NO. 06-09261-01 Amendment to Release Facility for Unrestricted Use.

To Whom It May Concern:

We request an amendment to release our "Present Nuclear Medicine – Main Area" for unrestricted use, so that we may proceed with the renovations described with diagrams in our previous letter dated 9/8/08.

We completed our move of all radioactive material from our old hot lab to the temporary hot lab, and ceased all use of radioactive material in this area on 9/21/08.

On 9/22/08, Bob Brouillette, Manager of Nuclear Medicine, conducted a closeout survey of the "Present Nuclear Medicine – Main Area" which included the hot lab. Survey readings showed no readings above background (i.e. ≤ 0.02 mR/hr). Wipe tests were also performed on all workspaces, floor areas, and equipment remaining in the rooms. No removable activity above background was detected (i.e. ≤ 200 dpm/100cm²).

These areas will continue to be restricted until we receive approval from your office. Since it is important for patient care, would you kindly expedite approval of its release, so we may proceed with this project.
