Review of Bellefonte Response to Request for Additional Information No. 01-07 for Applicability to the Vogtle Electric Generating Plant Units 3 and 4 Combined License Application

Ladies and Gentlemen:

Southern Nuclear Operating Cómpany (SNC) has reviewed Tennessee Valley Authority's (TVA's) response to U.S. Nuclear Regulatory Commission (NRC) Letter No. 071 request for additional information (RAI), submitted to the NRC on August 29, 2008 for proposed Bellefonte Nuclear (BLN) Units 3 and 4, Docket Nos. 52-014 and 52-015, for applicability to the Vogtle Electric Generating Plant (VEGP) Units 3 and 4 Combined License (COL) Application. NRC Letter No. 071 contains one RAI (No. 01-07) concerning regulatory guide conformance. TVA's response to RAI No. 01-07 includes BLN COL application changes to Final Safety Analysis Report (FSAR) Table 1.9-201, "Regulatory Guide/FSAR Section Cross-References." Our review has determined that the response to RAI No. 01-07, which is identified as a standard response for S-COLAs, partially applies to the VEGP Units 3 and 4 COL Application (VEGP COLA). The differences are primarily due to the VEGP COLA referencing the Vogtle Early Site Permit Application for discussion of selected regulatory guides in FSAR Table 1.9-201, instead of referencing applicable FSAR sections as the BLN COL application does. The VEGP COLA will adopt the revised portions of FSAR Table 1.9-201 with the following exceptions:

- Changes to Regulatory Guides 1.21, 1.59, 1.101 and 4.7 will not be incorporated;
- Changes to Regulatory Guides 1.26, 1.29, 1.60, 1.76, 1.78, 1.112 and 1.183 will be incorporated, but the existing 'Note b' in the "FSAR Chapter, Section, or Subsection" column of VEGP COLA's FSAR Table 1.9-201 will be maintained; and
- The addition of Regulatory Guide 1.110 will be incorporated, but the specified FSAR subsections under the "FSAR Chapter, Section, or Subsection" column are changed to "11.2.3.5" and "11.3.3.4."

These changes will be incorporated in a future revision of the VEGP COLA.
