The purpose of this modification is to:

1. Increase the contract ceiling.

Contract NRC-10-07-399 is hereby modified as follows:

1. The ceiling of the contract is hereby increased by \$27,880.70 from \$569,119.30 to \$597,000.00.
2. Incremental funding in the amount of \$65,000.00 is hereby obligated. Funds are increased by \$65,000.00 from \$532,000.00 to \$597,000.00.
