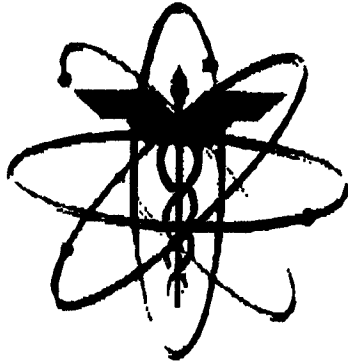

To Whom It May Concern:

This letter is to affirm that Joseph Annibali, M.D. received training and experience in Brain Imaging and localization studies at our institution, Amen Clinics, Inc. The preceptorship began on December 18, 2007 and continued until June 22, 2008.

During this training program Dr. Joseph Annibali received no less than 500 hours of supervised work experience and not less than 500 hours of supervised clinical experience. The experience of Dr. Joseph Annibali was gained under the supervision of an authorized user.

The supervised work experience included ordering, receiving, and unpacking radioactive materials safely and performing the related radiation surveys; Calibrating dose calibrators and diagnostic instruments and performing checks for proper operation of survey meters; Calculating, measuring and safely preparing patient dosages; Using administrative controls to prevent misadministration of byproduct material; Using procedures to safely contain spilled byproduct material and using proper decontamination procedures.

The supervised clinical experience included examining patients and reviewing their case histories to determine their suitability for radioisotope diagnosis, limitations, or contraindications, selecting the suitable radiopharmaceuticals and calculating and measuring the dosages, administering dosages, administering dosages to patients and using syringe radiation shields, collaborating with the Authorized User in the interpretation of radioisotope test results and patient follow-up.
