**PROGRAM SCOPE**

The licensee is permitted to use byproduct material under 10 CFR 35.100 and 35.200. The licensee has two locations of use and is authorized to perform licensed activities at temporary job sites. Since the last inspection, the licensee has not performed licensed activities at temporary job sites. The main facility is at the Salem facility. No licensed material is delivered to the Houston facility via the pharmacy. The licensee's hours at the Salem facility are 7am to 2pm; Monday and Thursday. The Houston facility is used once per week, typically on Friday's. The licensee administers licensed material to 1-2 patients per day. The licensee only receives Tc-99m in unit doses from a pharmacy in Springfield, Missouri. The licensee has one technician working part time in the nuclear medicine department.

**Performance Observations**

The inspector interviewed the licensee's technician and Radiation Safety Officer; each individual had adequate knowledge to ensure the safe use of licensed material. The licensee demonstrated radiation safety practices and radiological measurement equipment which were adequate to ensure compliance with NRC regulations. The inspector reviewed the licensee's dosimetry records, inventories, radiation safety committee meeting minutes and administration records; No abnormal issues were identified.
