The U. S. Nuclear Regulatory Commission (NRC) has received a request from Crow Butte Resources, Inc. (CBR) amend Source Materials License SUA-1534. CBR is located in Crawford, Nebraska and is licensed by the NRC to recover and process uranium by the *in-situ* leach extraction process. CBR has submitted an application to the NRC to develop a new satellite facility to the main CBR plant, which will be located in Sections 21, 22, 27, 28, 33, and 34 of Township 32 North, Range 52 West, Dawes County. The proposed development area is referred as the North Trend Expansion Area and its processing facility will be located approximately 6 miles northwest of the main CBR facility (see Enclosure 1).

As established in Title 10 *Code of Federal Regulations* Part 51 (10 CFR 51), the NRC regulation that implements the National Environmental Policy Act of 1969, as amended, the NRC is preparing an environmental assessment (EA) for the proposed action (i.e., the addition of the North Trend Expansion Area). In accordance with Section 106 of the National Historic Preservation Act, the EA will include an analysis of potential impacts to historic and cultural resources. To support the environmental review, the NRC is requesting information from the Tribal Historical Preservation Officer to facilitate the identification of historic and cultural resources that may be affected by CBR's license amendment request. Any information you provide will be used to enhance the scope and quality of our review in accordance with 10 CFR 51 and 36 CFR 800. After reviewing all the information collected, the NRC will prepare a draft EA and will provide your office an opportunity to comment.

Per a telephone conversation between Stephen J. Cohen, NRC's Project Manager, and Elizabeth Lorina, Oglala Sioux Tribe's counsel, on September 15, 2008, attached is the location of the Indian camp discussed in CBR's North Trend application (Enclosure 1). This information is being released to you by authority of the State of Nebraska. This information should be considered privileged; therefore, it should not be released to the general public without consent of the Nebraska State Historic Preservation Office.

CBR's license applications are publicly available in the NRC Public Document Room (PDR) located at One White Flint North, 11555 Rockville Pike, Rockville, Maryland, 20852, or from the NRC's Agency-wide Documents Access and Management System (ADAMS).
