Dear Mr. Colvin:

Enclosed is Amendment No. 27 to your NRC Material License No. 12-10243-01 in accordance with your request. Please note that some of the changes made to your license may be printed in **bold** font.

Please review the enclosed document carefully and be sure that you understand all conditions. If there are any errors or questions, please notify the U.S. Nuclear Regulatory Commission, Region III office at (630) 829-9887 so that we can provide appropriate corrections and answers.

Please note that I deleted all authorizations from your license at this time, except for carbon-14, as progress toward termination of this license continues. Several of your previous license conditions were also deleted, as they were no longer necessary.

I could not delete carbon-14 from your license and complete the termination of your license because the information in your letter dated August 28, 2008, was insufficient to complete my review. Please provide the following information, reference it as "additional information to control nos. 316874 and 317494" and put it to my attention. We will then continue our review.

- The closeout survey submitted for the Central Regional Laboratory did not include the type, make and model number of the instrument used for analysis of the wipes; the efficiency of the instrument used; and the corresponding conversion factor (cpm to dpm), including which radionuclide was used as a standard to determine instrument efficiency/conversion factor and the activity of the standard and counting data obtained with the standard.
- 2. During the site visit conducted by Ms. Patricia Pelke and me on August 7, 2008, one of the pieces of information I requested concerned the ADCO manifest form from your December 26, 2007, shipment, which needed to be signed by an appropriate ADCO representative as an "acknowledgment of receipt" for your radioactive waste. The missing signature belongs in the block just above block 10., along with the date of signature. As I recall, you were in the process of obtaining that document at the conclusion of the site visit. Please submit a signed and dated copy of this form.
