Please review the enclosed document carefully and be sure that you understand all conditions. If there are any errors or questions, please notify the U.S. Nuclear Regulatory Commission, Region III office at (630) 829-9887 so that we can provide appropriate corrections and answers.

Please note that in accordance with our telephone conversation on September 30, 2008, Item 17 in your letter dated was excluded from reference in LicenseCondition No. 19 of your license. You may in the future readdress this matter in greater detail.

You will be periodically inspected by NRC. Failure to conduct your program in accordance with NRC regulations, license conditions, and representations made in your license application and supplemental correspondence with NRC will result in enforcement action against you. This could include issuance of a notice of violation, or imposition of a civil penalty, or an order suspending, modifying or revoking your license as specified in the General Statement of Policy and Procedure for NRC Enforcement Actions. Since serious consequences to employees and the public can result from failure to comply with NRC requirements, prompt and vigorous enforcement action will be taken when dealing with licensees who do not achieve the necessary meticulous attention to detail and the high standard of compliance which NRC expects of its licensees.

Please note that by License Condition you are required to comply with the requirements of the "Order Imposing Increased Controls" (ADAMS Accession No. (ML053130218) published in the Federal Register on December 1, 2005 (70 FR 72128); and with the "Order Imposing Fingerprinting and Criminal History Records Check Requirements for Unescorted Access to Certain Radioactive Materials" (Fingerprinting Order) (ADAMS Accession No. ML073230831) published in the Federal Register on December 13, 2007 (72 FR 70901). This License Condition requires that you complete implementation of said requirements by the first day that radionuclides in quantities of concern are possessed at or above the limits specified in "Table 1: Radionuclides of Concern" contained within the fingerprinting Order, and notify, in writing, the
