Dear Dr. Torres:

This is in reference to your letter dated October 16, 2008 requesting to amend Nuclear Regulatory Commission License No. 52-19547-01. In order to continue our review, we need the following additional information:

Our letter dated September 12, 2008, requested that you provide information regarding Daniel Torres' experience in using radioactive materials. We need this information to determine if he has sufficient training and experience with the types and quantities of materials specified on your license.

The curriculum vitae that was submitted with your letter does not address the specific information that we requested. Although you state that Mr. Torres was named as a Radiation Safety Officer (RSO) and Medical Physicist on NRC licenses, you did not specify the NRC license numbers on which he was named by the NRC. In addition, I was unable to identify any NRC license issued to the Ponce Oncologic Hospital or the Mayaguez Medical Center; and cannot identify NRC licenses for any of the facilities where he is/was a consultant, except for the Ponce School of Medicine and the San Juan Health Center (terminated in 2001).

Please provide information describing the types of radionuclides that Mr. Torres has used, the quantities that he used, where the experience was gained, the duration of the experience, and the types of uses. In addition, you may provide the license numbers for licenses on which he is currently, or was previously, named as a Radiation Safety Officer.
