Information about making a scoping comment can be found in the top most document listed under the NRC Documents section of the Harris website, namely "[Notice of Intent to Prepare an Environmental Impact Statement and Conduct Scoping Related to a Combined License for Shearon Harris Nuclear Power Plant, Units 2 and 3](#)".
