In accordance with the task order procedures of the subject contract, this letter definitizes Task Order No. 3. This effort shall be performed in accordance with the enclosed Statement of Work, and the Contractor's technical proposal dated September 4, 2008. Task Order No. 3 shall be in effect from October 1, 2008 through September 30, 2011, with a cost ceiling of \$151,853. The amount of \$141,780 represents the total estimated reimbursable costs (including \$1,876 for cost of facility capital), and the amount of \$10,073 represents the fixed fee for this task order.

Funding in the amount of \$20,000 is provided at this time. Of this amount, \$18,519 represents the funded estimated costs and \$1,481 represents the fixed fee. It is estimated that this amount will cover performance through January 31, 2009.
