Dear Mr. Grecheck:

On August 22, 2008, the Federal Emergency Management Agency (FEMA) Radiological Emergency Preparedness (REP) Branch Chief issued a letter to the Nuclear Regulatory Commission (NRC), subject: Interim Finding Report for the North Anna Power Station Combined License (COL) Application. This letter provided results from the FEMA Region III REP Program staff review of offsite radiological emergency response plans provided in the COL application. FEMA found that the current plans are sufficient to protect the health and safety of the public, and that there is reasonable assurance the appropriate protective measures can and will be applied offsite in the event of a radiological emergency.

In another letter, also dated August 22, 2008, subject: Request for Additional Information (RAI) for the North Anna Power Station, the FEMA REP Branch Chief provided Dominion a list of RAIs related to the COL application. These RAIs concern matters under the cognizance of the Commonwealth of Virginia and the communities around the North Anna site. We have developed responses addressing each RAI and providing them in the attachment to this letter. It is understood that Dominion will forward this information to the FEMA REP Branch Chief from which FEMA will prepare a statement of reasonable assurance for the COL application.

Subject: Capabilities and Availability of Radiological Laboratories

Basis: NUREG-0654 Evaluation Criterion C.3 SRP ACCEPTANCE CRITERION: Requirement H

The Commonwealth of Virginia RERP, Appendix 2, Section I.C, Task Assignments, Division of Consolidated Laboratory Services, states that the Consolidated Laboratory Services will provide emergency laboratory services to State agencies and political subdivisions. However, the capabilities and expected availability of the laboratory are not specified. Provide information about the general capabilities and expected availability of the Division of Consolidated Laboratory Services to provide analysis services.

#### Response

The Commonwealth of Virginia Department of General Services Division of Consolidated Laboratory Services (DCLS), also known as Virginia Commonwealth Laboratories, provides analytical testing services. DCLS may be called on to respond to various health and environmental emergencies in Virginia. Its Bureau of Analytical Services performs analytical testing for state regulatory, environmental, and public health programs. Laboratories are located in Richmond and Abingdon, Virginia. Water, sediment, tissue, air, soil, and other samples may be analyzed for the presence of metals and/or radiation by its Metals/Radiochemistry Group.

# RAI North Anna - 002 A.2 Commonwealth of Virginia

The Commonwealth of Virginia RERP, Annex H, ESF #8, Tab B, Public Health and Medical Services, Radiological Laboratories list secondary laboratories at the Medical College of Virginia and the University of Virginia Medical Center. However, the capabilities and expected availability of the secondary laboratories are not specified. Provide information about the general capabilities and expected availability of the secondary laboratories to provide analysis services.

#### Response

The Virginia Commonwealth University Medical Center (historically known as the Medical College of Virginia) Office of Environmental Health & Safety (OEHS) Radiation Safety Office oversees the use of radioactive material and radiation-producing devices, conducts surveys for contamination and monitors radiation exposures.

The University of Virginia (UVA) Office of Environmental Health and Safety Radiation Safety Office manages all aspects of the use of radioactive materials and radiation producing equipment at UVA. The Radiation Safety Office controls and monitors radiation exposures to employees exposed to radiation during their work, calibrates radiation survey instruments and conducts radiation surveys.

Requisite law: § 32.1–102.2(C), Code of Virginia. These facilities shall meet and satisfy the regulations and requirements of the Commonwealth of Virginia.

#### **Proposed Plan Change**

No changes to the COVRERP are proposed.

#### RAI North Anna - 002 A.3 Commonwealth of Virginia

The Virginia Department of Health/Division of Radiological Health ERP, Appendix 5, Section 2.2.3.3, Accident Assessment, states that laboratory services will be provided by their own mobile laboratory or by the Consolidated Laboratory. However, the capabilities and expected availability of the laboratory are not specified. Provide information about the general capabilities and expected availability of the laboratories providing analysis services.

#### Response

The Virginia Department of Health (VDH), Office of Epidemiology, Radiological Health Program, Mobile Incident Command/Radiation Laboratory provides mobile radiological laboratory services



for a commercial nuclear power plant accident, analytical services for the environmental monitoring program, and serves as a Mobile Incident Command Vehicle. The Radiation Laboratory has detectors for gamma analysis and alpha/beta counting. Portable instrumentation includes Geiger-Müller survey meters with stick probes and pancake probes, alpha scintillation survey meters and probes, micro-R meters, radionuclide identifiers with neutron detection capability, survey meters with extendable probes, and air samplers with tripods and external battery supply.

VDH has two vehicles that are capable of providing mobile radiation laboratory services and provide support to the state field monitoring teams. The laboratory services are limited to analysis of environmental samples. One vehicle designated as the Field Lab can support the plume phase of nuclear power plant release. The other vehicle is the Mobile Incident Command Laboratory and has equipment with detection limits adequate to respond to both plume and ingestion pathway phases of a nuclear power plant radiation release.

Both vehicles are continuously available to respond to any radiological incident and may be mobilized upon a declaration of an "Alert" notification. They are currently parked at a location within a mile of Interstate 95 in Chester, Virginia approximately equidistant to the two nuclear power stations in Virginia, North Anna and Surry. There are pre-designated staging areas for the mobile radiation laboratory and State field teams. For the North Anna Nuclear Power Station, the staging areas are at Louisa and Post Oak Virginia Department of Transportation facilities. Both facilities have shore power connections for either vehicle and two telephone lines for voice and fax transmissions.

The Field Laboratory is a 2004 Ford E450 Ambulance body with electrical generator. The laboratory equipment consists of:

- In situ High purity germanium detector for gamma analysis
- Alpha/beta solid state detector for alpha/beta counting

In addition the vehicle carries portable field monitoring equipment:

- GM survey instruments with stick and pancake probes for gamma/beta radiation
- Alpha probes
- microR meters
- sodium iodide probes
- · air pumps with battery, tripod, charcoal or silver zeolite cartridges
- soil, vegetation and water sampling supplies
- personnel dosimetry
- KI tablets

The Mobile Incident Command Laboratory is a 2007 Pierce Enforcer. It has a conference room in the back, a communications center in the cab with radio, internet, satellite phone, and Direct TV.



The laboratory equipment consists of:

- High purity germanium detector with 2,000 lb shield for gamma analysis
- Sodium lodide detector in 250 lb shield for gamma analysis
- Alpha/beta solid state detector for low level environmental alpha/beta counting
- Liquid scintillation counting for tritium and other low energy beta emitters

In addition the vehicle carries portable field monitoring equipment:

- GM survey instruments with stick and pancake probes for gamma/beta radiation
- Alpha probes
- microR meters
- sodium iodide probes
- · air pumps with battery, tripod, charcoal or silver zeolite cartridges
- soil, vegetation and water sampling supplies
- personnel dosimetry
- KI tablets

The Louisa County RERP, Appendix 2, ESF #2 — Communications Procedure, and Appendix 5, ESF #5 — Emergency Management Procedure, state that at an Alert declaration or higher, the communications officer is to complete the "Notifications for an ALERT Declaration." The procedure for mobilizing response personnel is not included in the RERP. Provide information on the procedure to mobilize response personnel.

#### Response

Each risk jurisdiction maintains an Alert and Call Out Notification List for use during an emergency situation at North Anna Power Station. This list is maintained separately from the Radiological Emergency Response Plan (RERP) for confidentiality and due to the frequency of changes to the information. The Alert and Call Out Notification List is based on the Emergency Classification Levels (ECLs) and the actions required for each level.



The Alert and Call Out Notification List(s) may be reviewed at the Virginia Department of Emergency Management Trade Court Facility. Subject to extent of play agreements, it is anticipated that these instructions may be evaluated during the integrated exercise prior to fuel load.

Section VII.A.5 organization, Department of Mental Health and Mental Retardation, states that the department will maintain a



list of mentally handicapped persons who would require assistance during a radiological emergency; however, the methods used to develop this list are not described. Provide information on the identification of the special needs populations.

#### Response

Local social services agencies are tasked with the responsibility to identify and manage special needs individuals residing within the 10 mile EPZ and mental health agencies are tasked with the responsibility to maintain a list of mentally handicapped persons who would require assistance during a radiological emergency. Representatives of these agencies are present in the local EOC and work in coordination with the local emergency management coordinator and other decision making officials to ensure that the needs of these individuals are met in an emergency. The ability to address this population group at the local level is exercised and evaluated biennially.

#### RAI North Anna - 005 A Louisa County

Subject: Administrative and Physical Means for Notlfying and Providing Information to

the Public

Basis: NUREG-0654 Evaluation Criterion E.6 and J.10.c

SRP ACCEPTANCE CRITERION: Requirement H

The Louisa County RERP, Section VIII.D, Concept of Operations, Alerting, states that back-up route alerting will be performed if all or part of the siren system fails to function. Appendix 1, Emergency Management ESF Procedure, states that the sheriff's department is to perform route alerting in failed sirens areas and references the "North Anna Siren Manual." Appendix 4, Law Enforcement ESF Procedure, includes information for route alerting for areas not covered by sirens; however, it does not including information for routes corresponding to failed sirens nor does it reference the appropriate information. Provide information on the routes corresponding to the sirens should the siren system fail.

#### Response

The North Anna Power Station "Backup Route Alerting and Siren Manual" lists each siren by number, contains a map showing the area covered, and provides detailed instructions describing the route that the mobile alerting team is to follow.

Provide specific field monitoring procedures, including activation, notification means, field team composition, transportation, communication, monitoring equipment and estimated deployment times.

VDH/DRH – ERP Appendix 3, Notification, addresses notification and activation processes and Appendix 6, Communications, addresses communications.

Appendix 17.1 Monitoring and Sample Team Procedures are the procedures for the field monitoring teams. Appendix 17.1 Section 1.0, Purpose as well as other sections describe composition of field teams. The Division of Radiological Health have access to four state-owned vehicles with radios installed for emergency response activities, not including the two mobile radiation laboratory vehicles. Estimated time to deploy to either staging area (Louisa VDOT and Post Oak VDOT) is approximately 1½-2 hours during business hours and 2-3 hours after hours.

Subject: Air Sampling Procedures

Basis: NUREG-0654 Evaluation Criterion I.9 SRP ACCEPTANCE CRITERION: Requirement H

The Commonwealth of Virginia RERP, Appendix 6, Accident Assessment, and Virginia Department of Health/Division of Radiological Health (VDH/DRH) ERP, Appendix 5, Accident Assessment, indicate that the VDH/DRH field monitoring teams have the capability to detect radioiodine in the presence of noble gas at levels of 10<sup>-7</sup> uCi/cc through the use of air samplers with silver zeolite cartridges. No specific procedures were provided from the state for the process of collecting air samples, location of sampling points, and techniques to collect and count air samples. Provide specific field monitoring procedures for air sampling that ensure the capability to detect radioiodine at the required level.

#### Response

There are two procedures, one addresses field analysis using portable survey instrument and the other addresses using laboratory analysis.

VDH/DRH – ERP Appendix 5 discusses operational capabilities to detect radioiodine in the presence of noble gases at levels of 10<sup>-7</sup> uCi/cc through the use of air samplers with silver zeolite cartridges.

Appendix 17.4, LEOF procedures Section 5.3 shows the calculations from a survey instrument reading and Appendix 17.6, Staging Area, Attachment 10 is the Laboratory Sheet showing calculations for an air sample in the mobile lab.

These documents may be reviewed at the Virginia Department of Emergency Management Trade Court Facility. Subject to extent of play agreements, it is anticipated that these procedures may be evaluated during the integrated exercise prior to fuel load.

#### RAI North Anna - 016 A Commonwealth of Virginia

Subject: Dose Assessment

Basis: NUREG-0654 Evaluation Criterion I.10 SRP ACCEPTANCE CRITERION: Requirement H

The Virginia Department of Health/Division of Radiological Health (VDH/DRH) ERP, Appendix 5, Accident Assessment, states that the estimation of integrated dose from the projected and actual dose rates and comparisons with EPA PAGs will be performed at the Emergency Operations Facility by VDH/DRH personnel. No procedures for estimating integrated dose from



the projected and actual dose rates and for comparing these estimates with the protective action guides were provided for review. Provide procedures for dose assessment and EPA PAG comparisons.

#### Response

VDH/DRH – ERP, Appendix 5 Accident Assessment, Section 2.2 Operational Concepts and Procedures- Detection and Assessment addresses this responsibility.

Appendix 17.4, LEOF Section 4.0 describes the duties of the Assistant Radiological Assessment Officer (RAO). Among his duties includes the use of RASCAL, obtain source term data from the utility's Radiological Assessment Coordinator (RAC) and obtain data from the Field Team Coordinator. The Assistant RAO also compares the utility's atmospheric computer model, MIDAS, with the state's computer modeling software, RASCAL. RASCAL is a software program for atmospheric modeling the U.S. Nuclear Regulatory Commission provides to the states. RASCAL makes the comparison of integrated doses to the EPA PAGs.

Appendix 17.7, Offsite Dose Projection Computation Worksheet- is used whenever RASCAL is either not available or not working properly.

VDH bases its initial protective action recommendations on plant conditions. Staff responsible for accident assessment at the LEOF use field measurements as a basis for decision making for issuing KI to public and emergency workers.

Other field measurements or computer projections based on actual source term are used to confirm/verify initial protective actions were adequate to protect public health and safety.

The documents may be reviewed at the Virginia Department of Emergency Management Trade Court Facility. Subject to extent of play agreements, it is anticipated that these procedures may be evaluated during the integrated exercise prior to fuel load.

Subject: Onsite Personnel Evacuation Assistance Basis: NUREG-0654 Evaluation Criterion J.2 SRP ACCEPTANCE CRITERION: Requirement H

The Commonwealth of Virginia RERP, Appendix 5 Emergency Response, describes the planning for the emergency response, including evacuation plans and time estimates for the 10-mile emergency planning zone. The assistance that will be provided to North Anna Power Station (NAPS) during an evacuation and the provisions for coordinating arrangements with the offsite organizations to expedite the evacuation of onsite personnel are not included in the



plans. Provide information on the assistance that will be provided to NAPS during an onsite evacuation.

#### Response

North Anna would notify local law enforcement prior to an evacuation of onsite personnel. Local law enforcement, state police, and VDOT may provide assistance during an onsite evacuation.

#### **Proposed Plan Change**

The COVRERP will be revised to include this clarification no later than 30 days prior to the 2009 Surry biennial exercise.

#### RAI North Anna - 017 A.2 Commonwealth of Virginia

The remote assembly centers for onsite personnel during an evacuation of the North Anna site are not identified in the offsite plans. Provide information identifying the remote assembly centers.

#### Response

The remote assembly areas are identified in Figure II-4, Routes to Assembly Areas, of the COL Application.

#### **Proposed Plan Change**

The primary and secondary remote assembly areas locations and evacuation routes will be incorporated into the COVRERP no later than 30 days prior to the 2010 North Anna biennial exercise.

#### RAI North Anna - 017 B.1 Louisa County

The Louisa County RERP, NUREG-0654 Cross Reference indicates that this criterion is "not applicable." However, according to the COL Application, Figure II-4, Routes to Assembly Areas, the primary remote assembly area is located near Mineral, Virginia, in Louisa County. The secondary remote assembly area is located at North Anna Dam (located in Spotsylvania County) with travel through Louisa County before crossing into Spotsylvania County. The assistance that will be provided to North Anna Power Station (NAPS) during an evacuation and the provisions for coordinating arrangements with the offsite organizations to expedite the evacuation of onsite personnel are not included in the plans. Provide information on the assistance that will be provided to NAPS during an onsite evacuation.



### Response

North Anna would notify local law enforcement prior to an evacuation of onsite personnel. Local law enforcement may provide assistance during an onsite evacuation. North Anna Power Station evacuees to the secondary remote assembly area travel through and remain in Louisa County.

The remote assembly centers for onsite personnel during an evacuation of the North Anna site are not identified in the offsite plans. Provide information identifying the remote assembly centers.

#### Proposed Plan Change

The primary and secondary remote assembly areas locations and evacuation routes will be incorporated into the Louisa County RERP no later than 30 days prior to the 2010 North Anna biennial exercise.

#### RAI North Anna - 017 C.1 Spotsylvania County

The Spotsylvania County RERP, NUREG-0654 Cross Reference indicates that this criterion is "not applicable." However, according to the COL Application, Figure II-4, Routes to Assembly Areas, the secondary remote assembly area is located at North Anna Dam (located in Spotsylvania County). The assistance that will be provided to North Anna Power Station (NAPS) during an evacuation and the provisions for coordinating arrangements with the offsite organizations to expedite the evacuation of onsite personnel are not included in the plans. Provide information on the assistance that will be provided to NAPS during an onsite evacuation.

The secondary remote assembly area is located in Louisa County.

Subject: Protective Action Basis and Capability to Implement

Basis: NUREG-0654 Evaluation Criterion J.9 SRP ACCEPTANCE CRITERION: Requirement H

The Commonwealth of Virginia RERP, Section VII, Organization, states that the Virginia Department of Emergency Management coordinates the overall response and that the Virginia Department of Health, through the Radiological Health Program, provides technical advice and assistance on exposure control. The plans do not contain predetermined public Protective Action Decisions (PADs) based on plant conditions. Provide information on predetermined PADs based on plant conditions.

#### Response

The evaluation results are valid. Upon notification of a General Emergency declaration and receipt of a protective action recommendation (PAR) from North Anna, the Commonwealth of Virginia implements its Virginia Emergency Operations Center (EOC) action checklist for developing and implementing PADs.

The Virginia Department of Health (VDH) provides a technical assessment of the utility's recommendation for a PAR to the Virginia EOC. In the event, the Virginia EOC is not fully augmented at the time this notification is received, the Virginia EOC Duty Communications Officer will promptly notify the Virginia Department of Emergency Management (VDEM) Staff Duty Officer, convey the information and implement further actions as directed, including implementation of the Alert and Call Out Notification List. The VDEM Staff Duty Officer will coordinate with senior Commonwealth of Virginia decision-makers to determine protective actions for the public, including coordination with affected jurisdictions, activation of the Emergency Alert System (EAS), and deployment of field services.

COVRERP will be revised to describe the predetermined public PAD process for plant condition-based PARs no later than 30 days prior to the 2009 Surry biennial exercise.

### RAI North Anna - 018 A.2 Commonwealth of Virginia

Appendix 7, Tab A, Radiological Exposure Control, Protective Action Guides for the General Population, sets Protective Action Guidelines for protecting the general public during the emergency phase, but does not address protective action guidelines for the ingestion pathway phase and does not include the FDA Derived Intervention Levels. The plans are unclear as to who, by title, will make PADs for the ingestion pathway and who will implement the protective actions once those decisions have been made and communicated to the affected local governments and subdivisions. Provide ingestion pathway decision-making information including the title of the person making decisions and what organization will implement those decisions.

There is no Appendix 3, Tab E. Provide information for the local government ingestion pathway RERP plans.

Annex J, ESF #11 – Agriculture and Natural Resources, lists these same responsibilities and those of the Virginia Cooperative Extension. The COVRERP does not contain the following: the criteria for putting animals on stored feed; the identification and description of procedures for detecting contamination, for estimating the dose commitment consequences from the ingestion pathway and for imposing protective measures; and maps showing general crop information, farms, dairies, food



processing plants, watershed, water supply intake and treatment plants and reservoirs. Provide the information required by this criterion.

#### Response

The Virginia Department of Health is responsible for ingestion pathway protective measures as detailed in the response to RAI 029 A.2.

Maps showing general crop information, farms, dairies, food processing plants, watershed, water supply intake and treatment plants and reservoirs are available from the Department of Agricultural and Consumer Services.

#### **Proposed Plan Change**

COVRERP, Appendix 2, Section I.I, Task Assignments, will be revised to expand upon the description of the Virginia Department of Health's responsibilities for ingestion pathway protective measures no later than 30 days prior to the 2009 Surry biennial exercise.

#### RAI North Anna - 029 A.2 Commonwealth of Virginia

The Virginia Department of Health/Division of Radiological Health (VDH/DRH) ERP, Appendix 17, Standing Operating Procedures, lists SOPs for post-plume dose projection procedures and post-plume pathway package. However, these references were not available for review. The VDH/DRH ERP does not contain the following: the criteria for putting animals on stored feed; the identification and description of procedures for detecting contamination, for estimating the dose commitment consequences from the ingestion pathway and for imposing protective measures; and maps showing general crop information, farms, dairies, food processing plants, watershed, water supply intake and treatment plants and reservoirs. Provide the information required by this criterion.

## Response

VDH/DRH ERP, Appendix 17.8, Post Plume Dose Projection Procedure is the procedure for calculating the radiation dose or concentration levels that may require protective actions and Appendix 17.9, Post Plume Pathway Package is the protective action package for the ingestion phase.

The criteria for putting animals on stored feed is based on exceeding the EPA PAGs stated in Appendix 17.8 and is communicated via message #8 in Appendix 17.9.

In addition to the primary and back-up hospitals, Annex H, Tab A includes a list of "other hospitals with radiological response capabilities" and states that some of the hospitals listed do not have radiation detection equipment. It is not stated how hospitals that do not have detection equipment can have radiological response capabilities. The COVRERP does not specifically state that the listed hospitals have individuals on their staffs that are trained in handling radiologically contaminated persons with medical needs. COVRERP does not provide other relevant details about the listed hospitals, such as specific location and capacities for ambulatory and non-ambulatory individuals. Provide relevant information for the list of additional hospitals including qualifications to handle contaminated injured patients, equipment for radiological response capabilities, specific locations, and capacities for ambulatory and non-ambulatory individuals.

#### Response

The evaluation results are valid.

#### **Proposed Plan Change**

The COVRERP will be revised to reflect those hospitals that are qualified to handle contaminated injured patients and have equipment to perform radiological response functions no later than 30 days prior to the 2010 North Anna biennial exercise.

# RAI North Anna - 037 A Louisa County

Subject: Medical Transport of Contaminated/Injured Patients

Basis: NUREG-0654 Evaluation Criterion L.4 SRP ACCEPTANCE CRITERION: Requirement H

The Louisa County RERP, Appendix 10, Firefighting ESF Procedure, states that a Dominion Health Physicist will be available to the rescue [squad] to ride with the ambulance to the hospital and will conduct all monitoring of the patient. Information is not provided on how the Dominion



Health Physicist will meet the rescue squad at the appropriate location (if the contaminated injured individual is not at the North Anna Power Station (NAPS) site). Provide information on how contaminated, injured individuals will be monitored for contamination if the individual is a member of the public and not being transported from the NAPS site.

#### Response

The Louisa County RERP correctly provides for rescue squad assistance. However, the evaluation results are valid in that the Louisa County RERP does not currently describe how rescue squad assistance would handle contaminated, injured individuals or how individuals would be monitored for contamination if the individual is a member of the public and not being transported from the NAPS site.

## Proposed Plan Change

The Louisa County RERP will be revised to include how rescue squad assistance would handle contaminated, injured individuals or be monitored for contamination if the individual is a member of the public and not being transported from the North Anna site no later than 30 days prior to the 2010 North Anna biennial exercise.

## RAI North Anna - 037 B Caroline County

The Caroline County RERP does not contain EMS information about the transport of contaminated injured individuals who are members of the public. Provide information about the transport of contaminated injured members of the public.

The Caroline County RERP will be revised to include information about the transport of contaminated injured members of the public no later than 30 days prior to the 2010 North Anna biennial exercise.

The Commonwealth of Virginia RERP, Appendix 2, Task Assignments, discusses permanent relocation of individuals and households evacuated during the emergency phase; however, there are no procedures included for relocating people or households that were not evacuated but that may be in contaminated areas. Provide information for relocating persons that were not evacuated but may be in contaminated areas.

#### Response

The evaluation results are valid.

#### **Proposed Plan Change**

The COVRERP will be revised to include information for relocating persons that were not evacuated but may be in contaminated areas no later than 30 days prior to the Surry biennial exercise.

Appendix 11, Decontamination, Re-Entry, Return and Recovery, states the VDH dose levels for determining the need to relocate populations which is contrary to Federal guidance (EPA 400-R-92-001 states that the 50 year committed dose includes the first and second year whereas the stated dose in the COVRERP excludes the first and second years). Provide correct information on the dose levels for determining the need to relocate populations.

any county plan that address allowing evacuated persons or households to permanently return to an evacuation area. Provide information addressing procedures for evacuated persons to permanently return to an evacuated area.

The COVRERP will be revised to specify that instaphone (dedicated phone line that instantly connects all parties to share information), telephone, WebEOC, cell phone, VCIN (Virginia Criminal Information Network), and R.A.C.E.S. (Radio Amateur Civil Emergency Services) will be used to keep all involved response organizations informed of the recovery phase activities or changes that might take place in the organizational structure no later than 30 days prior to the 2009 Surry biennial exercise.

#### RAI North Anna - 040 A Commonwealth of Virginia

Subject: Total Population Exposure

Basis: NUREG-0654 Evaluation Criterion M.4 SRP ACCEPTANCE CRITERION: Requirement H

The Virginia Department of Health/Division of Radiological Health (VDH/DRH) ERP, Appendix 4, Emergency Response, indicates that the VDH/DRH will continue offsite monitoring, assessment, and environmental sampling until terminated by the Radiological Assessment Officer or when missions have been completed. Attachment 1, Section E, Recovery/Relocation/Re-entry, states that VDH/DRH will also maintain contact and coordinate the activities of Federal agency assistance. However, there is no information estimating the total population exposure from all pathways caused by the accident. Appendix 17 indicates that there is an SOP for post plume dose projection. This SOP was not provided for review. Provide information detailing the method used to estimate the total population exposure from all pathways as a result of the accident.



#### Response

VDH/DRH ERP, Appendix 17.8, Post Plume Dose Projection Procedure is the procedure for calculating the radiation dose or concentration levels that may require protective actions.

With respect to estimation of the total population exposure from all pathways as a result of the accident, VDH assumes calculated doses for areas within 10 mile EPZ could be assigned and would collaborate with other state agencies, such as VDEM to obtain population for those areas by sector and distance from reactor site, or perhaps by census tract. Their calculations would take credit for those evacuated from the evacuated sectors before the off site release.
