All,

Most of today's Board meeting was devoted to a lengthy discussion of differing opinions on interpretations of ground water protection regulation in Part 63. The primary question is whether a compliance demonstration with this regulation can consist of calculating the concentration by dividing the annual radionuclide flux by 3,000 acre feet of water (annual demand, also representative volume) or should the calculation consider the possibility of multiple years of contamination in a representative volume of 3,000 acre feet. The regulations do not suggest a compliance method. The YMRP language indicates the annual flux method to be appropriate. No conclusion was reached.

The Board decided to reconstitute the GW Panel. It will now include a Center member (Dr. Wittmeyer). The Panel is charged with developing recommendations that will be technically and legally defensible. The Panel will be free to discuss the subject with any staff including John Bradbury and Tim McCartin. The Panel will report its progress to the Board in two weeks.

The Board approved the charter of the SIR team. I will forward the email from Fred Brown on this subject.
