Subject: Environmental Report Update

Reference: 1) NEF-08-00221-NRC, Letter from LES to NRC, Emergency Plan and Fundamental Nuclear Material Control Plan Updates, dated September 4, 2008.

In accordance with 10 CFR 70.72(c), Louisiana Energy Services (LES) is allowed to make changes to Licensing Basis Documents under LES' approval authority. LES is required to furnish any changes made under such authority to the Integrated Safety Analysis in accordance with 10 CFR 70.72(d)(3) within 30 days of the end of the calendar year to the NRC. LES has previously been submitting changes to the Safety Analysis Report and Environmental Report at the same interval. LES will be submitting current revisions of all of our Licensing Basis Documents for the NRC to better prepare for the Hot Acceptance Testing Readiness Review.

Previously, LES submitted an update to the Emergency Plan and Fundamental Nuclear Material Control Plan on September 4, 2008 (Ref. 1). As a result of this submittal and with exception to the Integrated Safety Analysis and the Safety Analysis Report. all current revisions of LES Licensing Basis Documents have been transmitted to the NRC. This is due largely due to the fact that LES Security Documents and our Quality Assurance Program Description have requirements to submit changes within 30 days.

Therefore, LES is providing an update to the Environmental Report. Attached as Enclosure 1 are the marked up changes to the Environmental Report. Changes were made under revisions 10a, 10b, 10c and 10d and a description of each change is provided in the
