Recommendation 5: Re-certify and re-accredit the NRC Data

Center/Telecommunications System (DC/T).

Agency Response Dated

October 16, 2008: NRC completed certification and accreditation of the Data

Center Services system on June 3, 2008 (Authority to

Operate memo ML080230212 is available in ADAMS). NRC anticipates the Telecommunications System accreditation

decision in the 2nd quarter FY 2009.

OIG Response: The proposed actions address the intent of the

recommendation. OIG reviewed the Authority to Operate memo for the Data Center Services System and determined

that it is re-certified and re-accredited. However, the accreditation decision has not been made for the

Telecommunications System. Since this recommendation now addresses two separate systems, this recommendation will be closed when OIG reviews the accreditation memo for

the Telecommunications System.
