Public Meeting on Materials Reliability Program-169, Weld Overlay on Alloy 82/182 Dissimilar Metal Butt Welds

On October 23, 2008, the staff met with the industry to discuss the status of the industry's progress on the qualification of the ultrasonic examination of the optimized weld overlay. The weld overlay (full structural or optimized) is a method to repair or mitigate Alloy 82/182 dissimilar metal butt welds which are susceptible to primary water stress corrosion cracking in primary water reactors. The industry stated that the non-destructive evaluation qualification for optimized weld overlay is scheduled to be completed by end of 2008.

Prairie Island Nuclear Generating Plant License Renewal Pre-Hearing Conference

On October 29, 2008, the staff supported an Atomic Safety and Licensing Board (ASLB) pre-hearing conference on the contentions filed by the Prairie Island Indian Community concerning the Northern States Power Company's license renewal application for the Prairie Island Nuclear Generating Plant. Approximately 30 people attended the meetings, including Northern States Power Company representatives (the applicant), and members of the Prairie Island Indian Community. The ASLB provided its opening remarks, focused on issues specific to the 11 contentions, issues specific to the motion to strike, and provided its closing remarks.

Acceptance of the Exelon Nuclear Texas Holdings, LLC Combined License Application (COLA) for Two Reactors in Victoria County, Texas

On October 30, 2008, the staff informed Exelon Nuclear Texas Holdings, LLC that it had completed the acceptance review for the Victoria County Station Combined License (COL) application and the application has been accepted for docketing. This application is for a two unit economic simplified boiling water reactor in Victoria County, Texas. The staff plans to develop and issue a four phase schedule in early January for this subsequent COL. Development of this schedule will require approximately 60 days instead of the usual 30 days. The schedule will accommodate additional time for several safety tasks and the environmental review, to allow submittal of additional information by the applicant. The technical review of the COL application is scheduled to begin on November 3, 2008. The application is available in ADAMS (cover letter ML082540469), and on the public web site along with supplemental information provided by the applicant (<http://www.nrc.gov/reactors/new-reactors/col/victoria.html>).

State of Nevada; Denial of Petition for Rulemaking (PRM-2-14)

On October 22, 2008, the NRC published a notice (73 FR 62931) denying a petition for rulemaking submitted by the State of Nevada. The petition requested that NRC modify its regulation regarding issues specified for review in a notice of hearing for the Department of Energy application for a high-level waste (HLW) repository construction authorization at Yucca Mountain, Nevada. NRC denied the petition because it is inconsistent with current NRC rules and inconsistent with the Commission's intent when it established regulations requiring an opportunity for a hearing for all docketed HLW repository construction applications.

Protection of Safeguards Information (SGI); Final Rule (10 CFR Parts 2, 30, 40, 50, 52, 60, 63, 70, 71, 72, 73, 76, and 150, RIN 3150-AH57)

On October 24, 2008, the NRC published a final rule (73 FR 63545) amending its regulations for the protection of SGI to protect it from inadvertent release and unauthorized disclosure which might compromise the security of nuclear facilities and materials. The amendments modify the requirements for the protection of SGI with respect to persons, information, and materials subject to the regulations, as well as those that are not. The amendments reflect Commission Orders issued to licensees authorized to possess and transfer items containing certain quantities of radioactive material, amendments to the Atomic Energy Act (AEA) in the Energy Policy Act of 2005, and are within the scope of Commission authority under the Atomic Energy Act of 1954, as amended. Licensees and other persons subject to these regulations are required to implement these requirements, including any changes to security plans under these regulations, by February 23, 2009.

List of Approved Spent Fuel Storage Casks: NAC-UMS Revision 5 (AI48 - Part 72)

On October 27, 2008, the NRC published a direct final rule (73 FR 63621) that amends the NAC International, Inc., NAC-UMS Universal Storage System listing within the List of Approved Spent Fuel Storage Casks (Amendment 5). This amendment includes a number of specific changes to the certificate of compliance for this cask system. The direct final rule becomes effective January 12, 2009.

On October 27, 2008, the NRC published the companion proposed rule (73 FR 63655) to this direct final rule. The comment period closes November 26, 2008.

Contract Award for ADAMS Software Services

On October 23, 2008, as a result of a competitive, negotiated acquisition, an Indefinite Delivery, Indefinite Quantity Task Ordering type contract, NRC-33-09-342, was awarded to International Business Machines Corporation of Bethesda, Maryland, for Agency-wide Documents Access and Management System Software Services. This contract provides support services for the



FileNet document management software suite of products. The contract contains provisions for issuance of both firm-fixed price and time and material type task orders. The contract includes a base period of October 23, 2008 - October 16, 2009, and two 1-year option periods. The total value of the contract, including all options, is \$2,861,468.

Association of Records Managers and Administrators Conference

From October 20 to 23, 2008, staff attended the annual conference and exposition of the Association of Records Managers and Administrators in Las Vegas, Nevada. This year's expo floor showcased the latest products and services by over 200 of the top industry vendors including Oracle, IBM, and Google. Educational sessions attended included Blogging for the Enterprise, Strategic Alignment and Records and Information Management, Managing Active Electronic Records, Taxonomy Development, Developing an Information Management Program Model, as well as the U.S. Federal Government Day hosted by the National Archives and Records Administration (NARA). More than 4600 professionals attended from the fields of records management, information technology, corporate counsel, health care, business administration, government, archives and more.

Agencywide Documents Access and Management System (ADAMS) Public Users Group Semi-Annual Meeting

On October 29, 2008, staff participated in the semiannual meeting of the ADAMS Public User Group. There were 11 external attendees from organizations such as Westinghouse, Strategic Teaming and Resource Sharing (STARS), the State of Tennessee, Bechtel, HFC Controls, the Nuclear Energy Institute, Winston and Strawn, and General Electric Wilmington. Staff answered a number of questions submitted earlier through the ADAMS User Group distribution list and also presented an update on the Enterprise Content Management program. Questions addressed included status of the Citrix server change, problems in viewing the full list of documents retrieved in an ADAMS search, system "timing out" during a search, and plans for the future of ADAMS. A copy of the questions and answers will be stored in ADAMS and made publically available through the NRC public web site.

Federal Records Center (FRC) Program Forum

On October 29, 2008, staff attended the FRC Program Forum and the Bimonthly Records and Information Discussion Group (BRIDG) meeting hosted by the NARA in Washington, DC. The steep growth of NARA records holdings and the deployment of NARA's Archives and Records Centers Information System (ARCIS) were discussed at the FRC Forum. At the BRIDG meeting, NARA provided updates on the status of the Electronic Records Archive project, which, when fully deployed, will automate the submittal and approval of retention schedules and the transfer and subsequent preservation of Federal records.
