The Nuclear Regulatory Commission is invited to attend a roundtable discussion about the *Roadmap for Nuclear Defense Research and Development Fiscal Years 2010 – 2014*, issued July 2008 from the National Science and Technology Council's, Subcommittee on Nuclear Defense Research and Development (NDRD) with Dr. John Marburger, III.

The roundtable discussion will be held Tuesday, November 25, 2008, 1:30 – 3:30 pm in the Eisenhower Executive Office Building, room 445.

This Roadmap identifies national priorities to guide departments and agencies in the development of comprehensive and mutually supporting research programs that are closely linked to operational requirements. Recommendations and priorities are focused on five well-established and widely recognized mission areas: 1) nonproliferation in support of nuclear defense, 2) interdiction of nuclear and radiological materials, 3) render safe activities, 4) attribution (nuclear forensics), and 5) incident response and recovery. The Roadmap addresses the short-term needs of technology transition and operational necessity while also stressing the need for continuity of long-term basic science that has the potential to provide major capability improvements. The development of this Roadmap is an important step in our Nation's ability to confront nuclear and radiological threats. Implementation by the constituent departments and agencies will result in a robust set of capabilities to prevent and respond to the threat of nuclear terrorism.
