The purpose of this modification is to increase the obligated amount by \$4,944.75 from \$659,241 to \$664,185.75. Accordingly paragraph (c) of Section B.3, entitled "Consideration and Obligation - Cost Plus Fixed Fee (JUN 1988) Alternate I (JUN 1991)" is revised to read as follows: "(c) The amount currently obligated by the government with respect to this contract is \$664,185.75, of which the sum of \$615,835.75 represents the estimated reimbursable costs and of which the sum of \$48,350 represents the fixed fee."
