NOTIFICATION OF PLANNED SITE ACTIVITIES AS REQUIRED BY NORTH ANNA
EARLY SITE PERMIT

Pursuant to condition 3.G of Early Site Permit (ESP) No. ESP-003, Dominion Nuclear North Anna, LLC (DNNA) and Virginia Electric and Power Company (Dominion Virginia Power or DVP) hereby notify the Regional Administrator that Dominion Virginia Power¹ plans to begin certain site preparation and preconstruction activities listed below no earlier than 120 days from the date of this letter. We currently anticipate beginning these activities in calendar year 2009.

The activities involve preparation of the site, including activities such as clearing, grading, and construction of temporary access roads and preparation of borrow areas; utilities; excavation for facility structures and construction of service facilities (including items such as roadways, paving, railroad spurs, fencing, and exterior utility and lighting systems). The activities that DVP intends to commence will take place only in upland (i.e., non-wetland) areas and will not result in the discharge of fill material into or use of equipment in surface waters.

In accordance with condition 3.G of ESP-003, DNNA and DVP certify that all permits, licenses, and certifications required for these activities have been obtained. The specific authorizations include:

- A Phase I Land Disturbing Permit, ESCP 30-08, issued by the County of Louisa, VA, dated October 9, 2008

¹ On October 30, 2008, NRC issued an Order, subject to the conditions described therein, approving transfer of Early Site Permit No. ESP-003 from Dominion Nuclear North Anna, LLC to Virginia Electric and Power Company, doing business as Dominion Virginia Power (DVP), and Old Dominion Electric Cooperative. The activities described in this letter will not commence until transfer of the ESP and completion of the merger of DNNA into Dominion Virginia Power has occurred, as discussed in Dominion's letter dated August 14, 2008 (Serial No. NA3-08-103).


- An October 28, 2008 letter from the Department of Conservation and Recreation of the Commonwealth of Virginia confirming Dominion's registration and eligibility for coverage under the Virginia Stormwater Management Program General Permit for Discharges of Stormwater from Construction Activities (DCR01).

In accordance with condition 3.H of ESP-003, DNNA and DVP have obtained and are providing a determination from the Department of Environmental Quality of the Commonwealth of Virginia that certification under Section 401 of the Federal Water Pollution Control Act or Virginia Water Protection Permit is not required to support these activities. A copy of this waiver notification is enclosed.

Please note that no NRC review or approval of the activities described in this letter is required either under the ESP or in support of NRC's review of the North Anna Combined License Application. However, because the activities will occur on the existing North Anna site, Dominion Virginia Power proposes to provide NRC with a site tour to facilitate the staff's understanding of the activities. The meeting is also proposed because we would like to discuss implementation of condition 3.G of the ESP related to anticipated follow-on activities. We will coordinate with the appropriate NRC North Anna project managers to make the necessary arrangements.

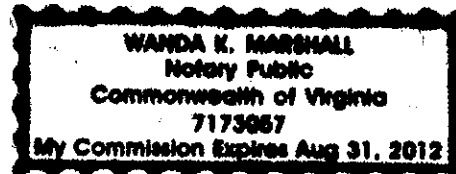

Notification of No Permit Required for Site Separation Activities at North Anna for Unit 3

Dear Mr. Hare:

The Virginia Department of Environmental Quality (DEQ), Virginia Water Protection (VWP) Permit Program received your email dated September 5, 2008 regarding the Site Separation Activities at North Anna for Unit 3. Unit 3 will impact surface waters and a Joint Permit Application for those impacts will be submitted. However, activities in upland (non-wetland) portions of the property are planned to commence prior to receiving a Virginia Water Protection Permit for the surface water impacts. In your email and during our phone conversation on September 11, 2008, you requested verification that no 401 Certification and/or Virginia Water Protection Permit would be required for commencing Site Separation activities conducted solely in the uplands.

Based upon the information that has been provided, commencing Site Separation Activities will not result in the discharge of fill material into or use of equipment in surface waters. Therefore, a 401 Certification or a VWP Permit from the DEQ-VWP Permit Program will not be required for these activities proposed in the uplands. You are advised that this does not give you the authority to violate Virginia's State Water Quality Standards.
