Dear Sir or Madam:

Entergy Operations, Inc., in Reference 1, transmitted electronic files of site meteorological data for use in independent analysis. Data related to a key parameter (temperature) was omitted from that file.

Enclosed is a CD-ROM containing hourly meteorological data, including temperature. The joint frequency distribution data files provided Reference 1 are still applicable. The met data file format and name on the CD-ROM do not fully comply with the requirements for electronic submission in NRC Guidance Document, *Guidance for Electronic Submissions to the NRC*, dated November 20, 2007, in that the files are not in portable document format (.pdf). The NRC Staff requested the files be submitted in their native formats required by the software in which they are utilized to support the FSAR development. The data file is in a format consistent with Regulatory Guide 1.23 guidance. The file names are those required for proper software operation.
