Darrell,

You had asked that DOE provide the level-line survey data used to create figures 6-1 and 6-2 in Keefer et al. (1996), and figures 3 and 4 in Keefer et al. (1997). On our last call on these requests, DOE noted that they had found an error in the latitude given in one of the figures. They then asked if the error was the only source of our info request, or were we looking for more. My impression was that it went beyond a possible error on the figure (although that was nice to discover), and that you wanted the actual leveling data so that you could replot the results.

I told them that I would confirm this with you. Please let me know if this is the case, or if there is some other aspect of these data that you were interested in. We will be speaking with them again this Wednesday afternoon, and I'd like to give them a definitive answer then.
