Kansas City offers a wide variety of activities and sites to visit including family-oriented activities such as the Kansas City Zoo, Union Station/Science City, Worlds of Fun Amusement Park, and the Deanna Rose Farmstead. For those who have an interest in nature, time should definitely be made to visit the Powell Gardens and the Overland Park Arboretum and Botanical Gardens. There is no shortage of shopping available in the area, either. A visit to the Country Club Plaza shopping/dining area is a must, and there are also several large shopping malls nearby.
