

1) 52.232-19: Availability of Funds for the Next Fiscal Year (APR 1984) is revised as follows:

No legal liability on the part of the Government for any payment may arise for performance under this contract beyond the current funding amount of \$100,000.00 (This can be any combination of office furniture), until funds are made available to the Contracting Officer for performance and until the Contractor receives notice of availability, to be confirmed in writing by the Contracting Officer.

2) Section A.1 Consideration and Obligation-Delivery Orders (JUN 1998), paragraph (b), sentence (1) is revised as follows:

"The amount presently obligated with respect to this contract is \$100,000.00"
