Just received the info attached regarding petition to block the Victoria docketing decision. OGC told me that apparently we made the docketing decision before this petition was submitted to the Commission. (The docketing letter was issued 10/30/08; I was several days ahead of schedule for the Victoria AR and beat the published 11/6/08 date on the public web.)

The petition was revised and resubmitted to delay the hearing notice, pending completion of rulemaking on the ESBWR DC. OGC has till Nov 13th to file their response to the Commission. This petition is similar to what submitted for Harris and the Commission decided to not put the review in abeyance. No resources are needed from the NRO at this time. OGC is handling this.
