**SUBJECT: TERMINATION OF YOUR NRC RADIOACTIVE MATERIALS LICENSE**

On facsimile dated October 21, 2008, you informed the U.S. Nuclear Regulatory Commission that you wished to terminate NRC License No. 50-27774-01. The supporting documentation provided by you stated that all radioactive material possessed under this license had been transferred to a licensed entity and that the latest leak test indicated that there was no leakage of radioactive material from the sealed sources. Based on this information and a review of your historical file, the staff concluded that all licensable radioactive material has been removed from your facility. Your facility located at 6710 Teshlar Drive, Anchorage, Alaska, is suitable for unrestricted use in accordance with 10 CFR 20.1402, "Radiological Criteria for Unrestricted Use." No further remediation or actions with respect to NRC regulated material is required. Therefore, NRC License No. 50-27774-01 is hereby terminated as stated in the enclosed Amendment No. 04 to the license. An environmental assessment for this licensing action is not required, since this action is categorically excluded under 10 CFR 51.22(c)(20)(ii).

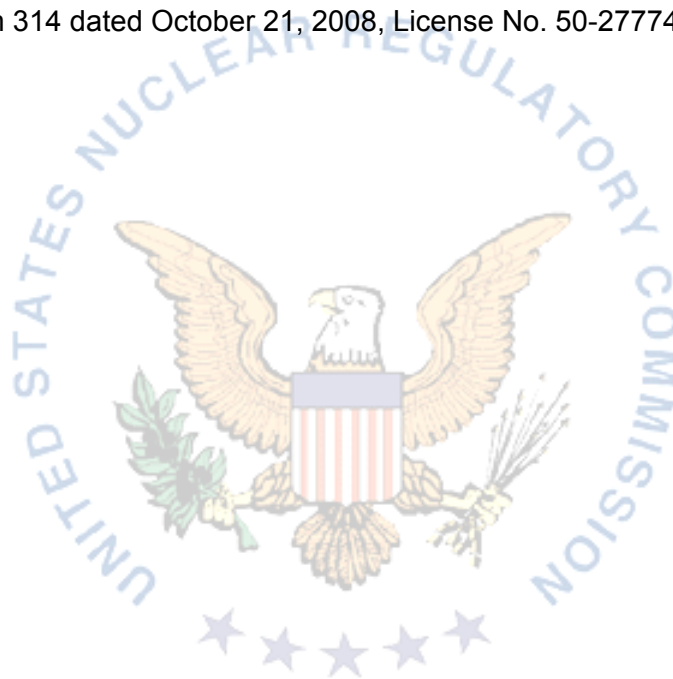
