The purpose of this modification is to (1) increase the task order ceiling, and (2) add incremental funding, as follows:

1. The COMEDO system is a very old funds tracking system which is based on very old Clipper software. OCFO needs to have this old system converted into a newer data base. Since this system tracks agency funds that are reconciled with the agency accounting system, thorough testing is required. The contractor needs to create/develop a Test Plan for the New COMEDO 05.00.00 (Commission EDO/IG Budget Tracking) Application and use the test plan for system testing and User Acceptance Testing. These steps are needed to deploy the New COMEDO 05.00.00 (Visual Basic) Application into production. This conversion effort requires an increase in the ceiling of this task order.

Therefore, the ceiling of this task order is increased by \$16,045.59, from \$14,545.01 to \$30,590.60. A revised cost schedule for Task Order 25, dated March 21, 2008, listing labor categories, hourly rates, and hours, for a total ceiling amount of \$30,590.60, is attached.

2. Incremental funding is added in the amount of \$14,000.00, thereby increasing the obligated amount from \$10,000.00 to \$24,000.00.
