By application dated June 3, 2008, the U.S. Department of Energy (DOE) requested the U.S. Nuclear Regulatory Commission (NRC) staff approval of a construction authorization.

NRC staff has reviewed the information provided in your submittal and determined that additional information is required in order to complete its review. Questions in the enclosed request for additional information (RAI) were e-mailed on November 25, 2008, and discussed in a telephone call with Ms Corinne Macaluso, et al., of your staff on December 4, 2008. During the discussion, NRC agreed to DOE's request that responses to RAI numbers 2, 3, 5, and 7 will be submitted by January 9, 2009, and responses to RAI numbers 1, 4, 6, and 8 will be submitted by January 16, 2009. Also, NRC agreed to make a correction to RAI number 3.

NRC staff considers that timely responses to RAIs help ensure sufficient time is available for staff review to meet its 10 CFR Part 2 schedule requirements and contribute toward the NRC's goal of efficient and effective use of staff resources.
