SUBJECT: SUMMARY OF DECEMBER 4, 2008, CATEGORY 2 MEETING
REGARDING THE NATIONAL FIRE PROTECTION ASSOCIATION
STANDARD 805 FREQUENTLY ASKED QUESTION PROCESS

On December 4, 2008, the U.S. Nuclear Regulatory Commission (NRC) staff held a meeting with stakeholders and the public to discuss Frequently Asked Questions (FAQs) at plants that are adopting National Fire Protection Association (NFPA) Standard 805. Licensees agreed to submit a new revision of FAQ 06-0008 in advance of the next FAQ meeting. Licensees introduced a revision of FAQ 08-0043, and submitted new FAQ 08-0051. The participants agreed that FAQ 08-0049, which was previously proposed to be withdrawn, be reinstated due to the importance of the issue. Licensees and the NRC staff discussed the remaining open FAQs. The participants determined that both industry stakeholders and the NRC staff needed to continue to work on the remaining open FAQs.

Industry representatives announced that they would publish their positions on the issues covered by FAQs 08-0044, 08-0046, and 08-0048 outside the FAQ process via a report to be issued in December 2008 by the Electric Power Research Institute.

NRC staff presented updated schedules for the review of the pilot plants' license amendment requests and development of NFPA 805 infrastructure.

Participants agreed that the next FAQ meeting would take place on January 22, 2009, via teleconferencing.
