Dear Sir or Madam:

In Reference 1, Entergy Operations, Inc. (Entergy) submitted an application for a combined license (COL) for Grand Gulf Nuclear Station (GGNS), Unit 3.

On December 2, 2008, a conference call was held with the NRC Staff to discuss key COLA Environmental Report (ER) impacts resulting from ESBWR Design Control Document (DCD) changes, GGNS-3 design changes, and Final Safety Analysis Report (FSAR) requests for additional information (RAI) responses. During this call the use of Mississippi River flow velocity data provided in the ER Subsection 2.3.3 and Table 2.3-205 was discussed.

This flow velocity data was collected in conjunction with a Mississippi River bathymetry and temperature survey used to support ER development but was not used in the ER for evaluation of impacts. In particular, this near-shore velocity data was not used as input to the CORMIX model for thermal plume analysis. Presentation of the data in the ER, and the fact that it was not used for analysis or evaluation of impacts, caused some confusion on the part of the NRC Staff reviewers as to the purpose of the velocity data.

As a result, it was agreed that the ER will be revised to remove the Mississippi River flow velocity data collected during this bathymetry/temperature survey. Specific revisions will include:

- Revising the text in ER Sections 2.3, 5.2.3, 5.3.2.1, and 6.1.1 to remove references to these flow velocity measurements
- Revising Table 2.3-205 to remove flow velocity data.
