PROGRAM SCOPE

The licensee was a private engineering, construction and environmental consulting company and employed 160 individuals at its Indianapolis office. The company also operated 36 field offices throughout the country. The Indianapolis office owned two moisture/density gauges which were used daily for highway/construction projects during the construction season. Six individuals were authorized to use the gauge (training certificates maintained on file by the RSO). The licensee did not perform any service or maintenance activities on its gauge; these services were performed by the manufacturer or a licensed service company.

During this inspection, the inspector toured the gauge storage room, interviewed licensee personnel, and reviewed selected records. At the time of this inspection the gauge was located at a jobsite in the Chicagoland area. The inspection included a review of the licensee's activities at this job site. At the time of the field inspection, the gauge was in secured storage within a trailer. The inspector surveyed the device and the storage room within the trailer; all survey results in unrestricted area were within Part 20 limits. Interviews with licensee personnel confirmed the gauge users' understanding of the security requirements in Section 30.34(i).

No violations of NRC requirements were identified during the scope of this inspection.
