FOCUS GROUP ON NEW REACTOR OPERATOR LICENSING

On December 3, 2008, the U.S. Nuclear Regulatory Commission (NRC) staff held a public meeting with the Industry Focus Group on new reactor operator licensing to discuss the project plan for the revision of the knowledge and abilities catalogs (K/A Catalogs). Enclosure 1 lists the attendees at the meeting; one member of the general public was present. Enclosure 2 is the agenda for the meeting.

This was the latest in a series of meetings intended to promote efficient, effective, and consistent preparation and administration of new reactor operator licensing examinations. The industry presented an overview of the plan to update the existing PWR and BWR K/A Catalogs and to develop two new K/A Catalogs. Updates to the existing K/A Catalogs for evolutionary new plants (US-APWR, ABWR, and EPR) will be completed as addendums to the current catalogs to ensure K/A Catalogs for existing PWRs and BWRs are not altered by this project. Two new K/A Catalogs are proposed for the passive nuclear power plants (AP1000 and ESBWR). It is the industry intention to submit the updates and new catalogs to the NRC in 2011. Topics of discussion included the use of international operating experience, impact of CRGR and ACRS review on the schedule, impact on the GFES, and the size of the SME group.

The NRC agreed to review the project plan and meet with the industry to discuss NRC comments and concerns.

In closing, it was decided that the next meeting related to the licensing and examination of reactor operators will be held in early 2009 to discuss the K/A Catalog revision plan. No final positions were taken during the meeting.
