Subject: 2 concerns for Progress Energy Plant Levy County Public Comment

I write to the NRC with the following two concerns on the public record regarding the expansion of a nuclear power plant facility proposed by Progress Energy for the Levy County Fla site.

1. It is site located in a very low coastal plain faced by a shallow bay to the Gulf of Mexico and within the latest FEMA slosh studies this flood plain is highly likely to be under between 15 and 25 feet of salt water storm surge each cat 3 or larger storm ...and the loss of this expanded level of state grid capacity would be catastrophihic to the state power supply needs.

2. The National Weather Service and NOAA along with the National Academy of Science all concur in the public record and in peer reviewed studies that we are in a period of global warming which causes super hurricane developments more and stronger storms for possibly for two more decades. The proposed location of this mass MW central plant in a very high risk coastal zone with modeled slosh destruction and with extensive heavy grid network reliance is of questionable engineering reasonableness and economic value under the storm damage/ surge federal risk base senerios of NWS NOAA and Lloyds.
