Subject: Request for License Renewal/Extension of Expiration Date

General Atomics (GA) possesses export license number XR166 for the export of a TRIGA® research reactor to the Government of Thailand. More specifically, the TRIGA® reactor is a light water cooled and moderated, heavy water and beryllium reflected, pool type, low-enriched uranium fueled reactor with a maximum thermal output of 10 Megawatts. The ultimate end user is the Ongkharak Nuclear Research Center of the Ministry of Science, Technology and Environment's Office of Atomic Energy for Peace. There has been only limited progress on this project and much remains to be done. Therefore, GA foresees a need to extend the expiration date of XR166 from 31 December 2008 to 31 December 2018.

Inasmuch as GA did not request this extension at least 30 days before the license expires, GA understands it cannot use the license beyond 12 December 2008 until such time as the Commission acts favorably on this request. Enclosed, please find a check in the amount of \$720.00 to cover the fee associated with this request.
